1. Purpose

The Copyright and Licensing Policy defines the ownership, usage rights, and permissions related to all content published in the journal.

This policy aims to protect the intellectual property of authors, ensure ethical use of published materials, and promote global access to scientific knowledge through open licensing.

The journal is committed to balancing author rights, academic transparency, and public access in accordance with international copyright laws and open access principles.

2. Copyright Ownership
